認識 RDA 歷時性作品 – 定義和理論架構



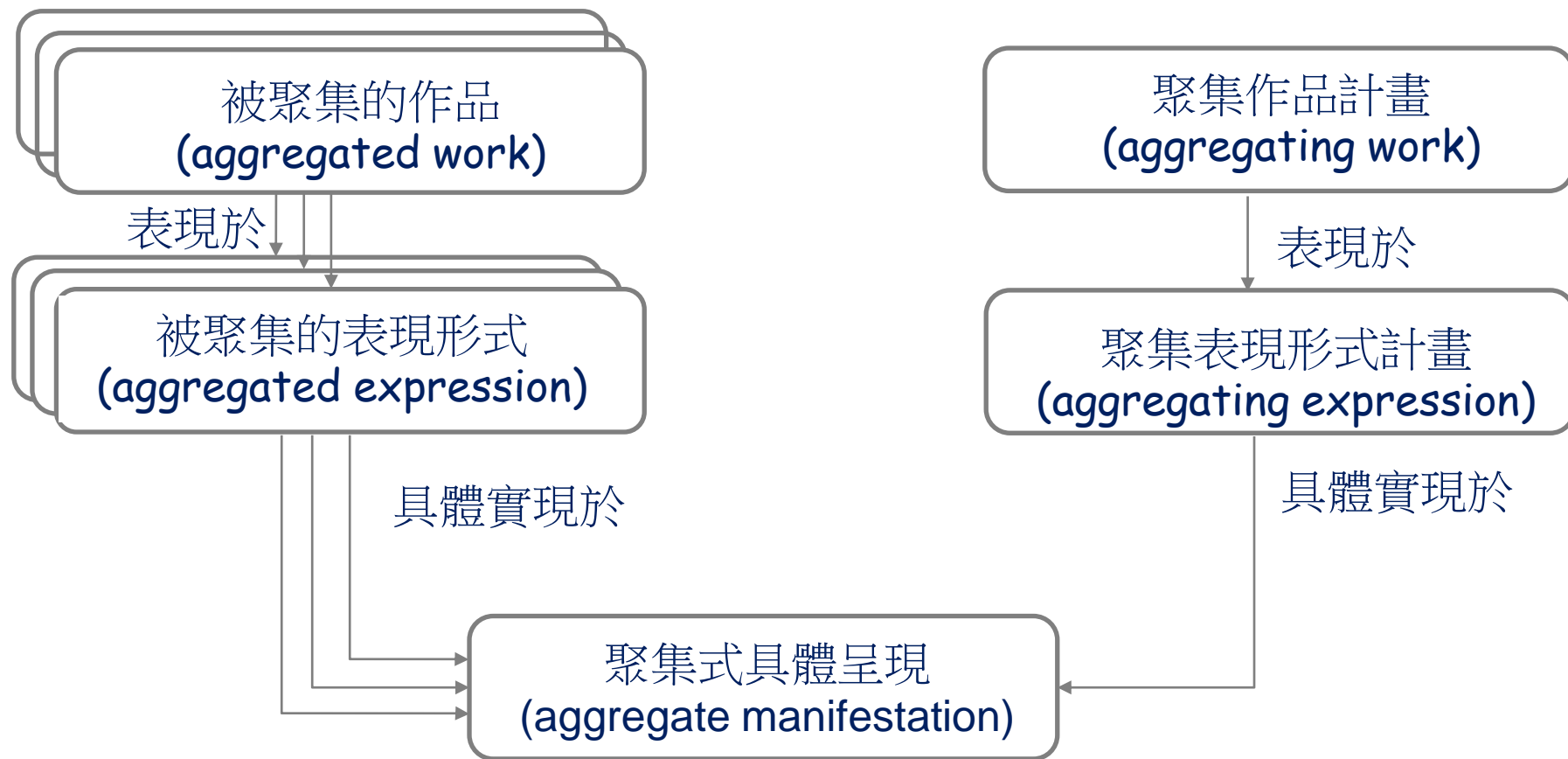
歷時性作品 (Diachronic Works) – RDA 定義

- » Diachronic – something has developed and evolved through time (一事物隨著時間，發展進化)
- » 歷時性作品 – 一作品有計畫以歷時性方式實現；在作品的創作、內容表現及實體實現的過程中，作品的內容隨時間推移改變，以分開的表現形式和具體呈現來實現 (Any resource planned to be issued over time)
- » 歷時性作品的本質是其計畫隨著時間推出不同內容的作品

IFLA 圖書館參考模型 (Library Reference Model)

- » RDA 歷時性作品理論架構
- » 聚集式資源 (5.7 Aggregates)
 - ◇ 實現多個表現形式的具體呈現 (a manifestation embodying multiple expressions)
 - ◇ 聚集式出版品的形成來自：
 1. 聚集作品和表現形式的計畫 (aggregating plan)
 2. 被聚集的作品和表現形式 (aggregated works)
- » 期刊 (5.8 Serials)
 - ◇ 連續發行的聚集式出版品 (a serially-issued sequence of aggregate manifestations)
 - ◇ **新理論**：一期刊作品只表現於單一表現形式，實現於單一具體呈現 (即作品-表現形式-具體呈現鎖定 [W-E-M lock])
 - ◇ 不同 (翻譯、語言、區域、媒體 (print vs. online)) 版本的期刊，均視為不同作品

IFLA 圖書館參考模型 - 聚集式出版品 (Aggregates)



RDA 歷時性作品 (Diachronic Work)

- » 一般來說，一作品可以一次性出版方式做實體實現，也可依順序陸續出版，一次性出版方式作品內容固定不變 (屬靜態作品)，連續出版的作品內容會經時改變 (屬歷時性作品)
- » 歷時性作品推出時，有兩種內容延伸方式
 - ◇ 經時間隔出版的作品內容累積 – extension by accumulation
 - ◇ 經由新作品取代舊作品 – extension by replacement

RDA 歷時性作品類型 (Types of Diachronic Works)

由兩因素決定：

- » 內容延伸方式 (content extension method)
 - ◇ 內容累積 (accumulation) – 連續性 (successive)
 - ◇ 經時間隔出版的作品內容累積，每一間隔發行的作品內容都保留、存在
 - ◇ 內容取代 (replacement) – 整合性 (integrating)
 - ◇ 經時間隔出版以新內容取代舊內容，早先發行的刊期被取代或整合，無法單獨取得
- » 發行期限意向 (issuance extension plan)
 - ◇ 有限期 (determinate)
 - ◇ 無限期 (indeterminate)
- » 編目工作 – 根據內容延伸及發行期限意向決定資源類型及描述方式

著錄方式及其他描述考慮

四種 RDA 著錄方式 (recording methods)

- 非結構性著錄方式 (unstructured description)：著錄元素資料沒有結構限制，不遵循任何控制詞彙及登錄格式
 - 原文照抄的轉錄著錄 (transcribing)
 - 自由書寫的附註項
- 結構性著錄方式 (structured description)：遵循特定結構格式來著錄的資料元素
 - 有些結構性資料可是控制詞彙系統
- 識別碼著錄方式 (identifiers)：著錄的元素資料是識別碼
- 國際資源識別碼著錄方式 (Internationalized Resource Identifier (IRI))

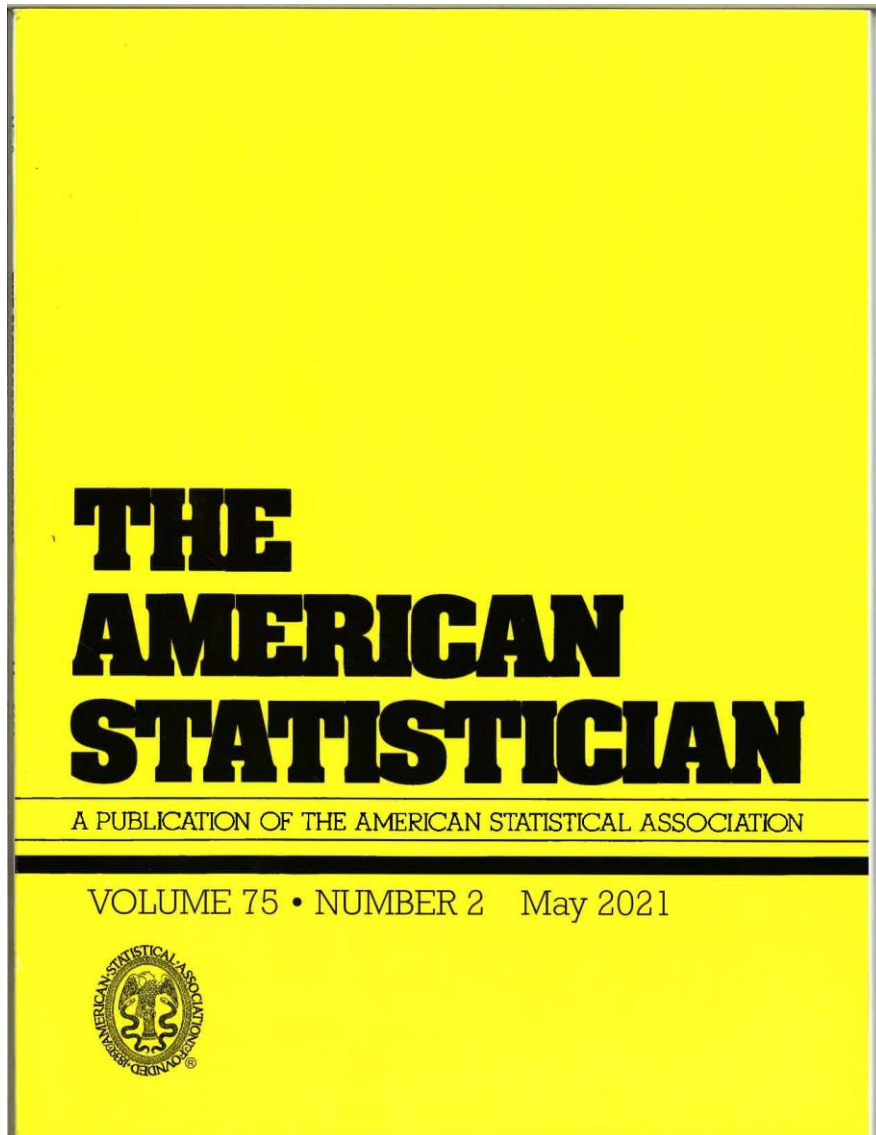

- 檢視編目資源是否有計劃、隨著時間推進，發行或出版不同內容的作品
- 若是，進一步決定此資源是連續性或整合性
 - 連續性資源：內容累積，有分開的刊期、部份
 - 整合性資源：內容整合，無法分辨個別的刊期
- 根據連續性或整合性資源的編目規則來著錄書目記錄

LC/PCC 編目決定：期刊

手邊的資源有意或已經出版多個獨立部分、或出版多次，與下列特徵一起使用，來決定作為單件圖書、多冊圖書、或是期刊編目：

A. 出版品的出版頻率：

1. 在資源上有頻率字眼，如月刊、季刊等，當作期刊
2. 如出版頻率在一或兩年內超過一次，當作期刊：如頻率是三年或更久，則當圖書



LC/PCC 編目決定：期刊

B. 雖然號碼編次不是決定期刊的必要條件，多數的期刊有號碼編次：

1. 在資源上有數字、字母、或年代編次，出版品有意持續出版（連續性－無限期發行計劃），當作期刊
2. 如在後來的刊期上，增有卷號編次，應重新編為期刊
3. 如資源頻繁出版，有類似編次可作為號碼，當為期刊



LC/PCC 期刊編目決定

C. 有類似〈連續性-無限期發行計劃〉("successive indeterminate plan") 的表示字眼，當為期刊。如資源上沒有明確表示，但有下例字眼，且有頻率及號碼編次：


1. 有下列字詞，"Advances in"、
"Development in"、或 "Progress in"，當為期刊；如是刊期有個別題名，分析各刊期
2. 資源可訂閱



LC/PCC 編目決定：整合性出版品

資源有意持續發行多個部分，但新內容的增加、更改或刪除均整合在一起，無法分辨個別部份


- 當作整合性出版品編目
- 如活頁冊用出版的部份更新，但每隔一固定時間增加一新的活頁冊用來裝更新的部份；如 **2022** 年活頁夾中有持續出版的更新部份，用來 **2022** 年的更新內容，在 **2023** 年又新增一新的活頁夾用來登錄 **2023** 年的資訊，作為期刊編目



書目記錄的描述根據 (source of metadata)




LC/PCC 編目來源

- 期刊 (**serials**) 出版品：以年代最早的刊期 (**earliest issue**) 為描述依據；若刊期年代最早的編號並不是最小，則以編號最小 (**lowest numbering**) 的刊期為描述依據；如無最早的刊期，則以手邊可得最早的刊期為依據
 - 整合性出版品 (**integrating resources**)：以最新、即時所見的整個資源 (**current iteration**) 為描述依據

LC/PCC 書目資料出處

如書目資料是書頁出版品，即由一頁或數頁 (pages)、葉 (leaves)、片 (sheets)、或卡片 (cards) 組成：
根據以下順序，選取書目資料出處：

1. 題名頁 (title page, title sheet, or title card)
 2. 封面 (cover)、書套 (jacket)
 3. 標題頁 (caption)
 4. 報頭題名 (masthead)
 5. 版權頁 (colophon)

CONDITION

The source of a *metadata work* is a manifestation that is being described.

A manifestation consists of one or more pages, leaves, sheets, or cards.

上下層元素

- 上層元素 (element supertype) 就是 broader element；下層元素 (element subtype) 就是 narrower element
- 在編目時，參考上層元素的規則；例如：





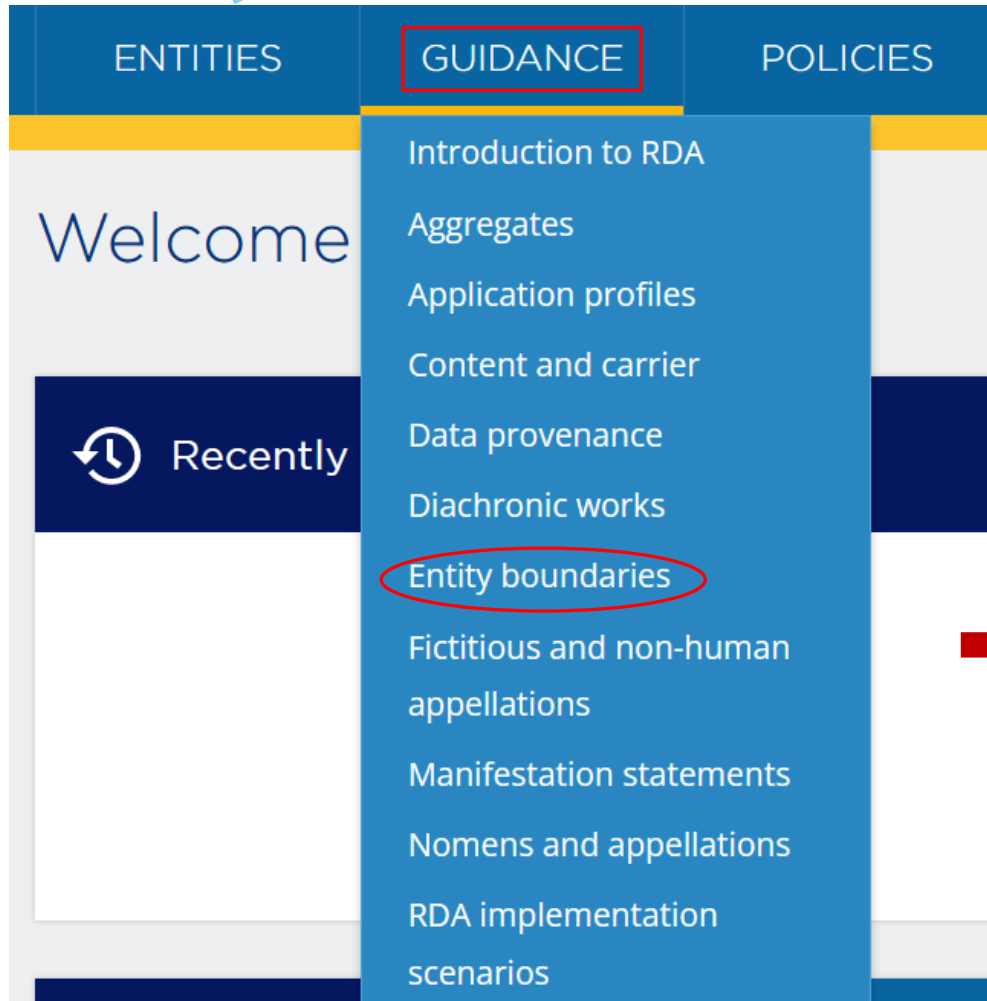


實體界線 (Entity Boundaries)

- » RDA 實體界線是一套準則，用來決定一作品是否應視為新作品，需著錄新書目紀錄

Entity boundaries

An RDA *entity boundary* is the set of criteria that is applied by an agent who creates metadata to determine if a description of a new RDA entity is required.

The criteria are specified as a difference in the values of one or more elements associated with a single entity.

The criteria may indicate a new entity of the same type, or of a different type. For instance, the criteria applied to an expression may determine that a new work is being described as well as a new expression.

Work

Entity boundary

The relative boundary of the entity is determined by bibliographic and cultural conventions.

A *static work* may be realized by two or more expressions that differ in content without changing the intellectual or artistic conception of the work.

An expression of a static work may be embodied by two or more manifestations without changing the content. A manifestation that carries the same content embodies the same expression and work.

A difference in content between two expressions is necessary but insufficient as an indicator that each expression realizes a different work. For instance, an expression that is a translation of another expression is not usually described as a realization of a different work. Instead, both expressions are described as realizations of the same work.

A *representative expression* may be used to establish the values that are compared to determine if an expression that is being described is a realization of a new work.

A common appellation may be used to collocate distinct works with common characteristics as a *work group*. This device can be used to harmonize the results of applying different work boundaries by different agents who create the metadata.

- Consider that "one spelling vs. another" applies both in the case of ordinary orthographic variations and in the case of official orthographic changes. Consider that "a change in grammatical form" includes singular vs. plural, adjective vs. noun, and genitive vs. nominative cases.

- the addition, deletion, or change of articles, prepositions, or conjunctions (or, in languages which do not use those, analogous parts of speech that have little lexical meaning but express grammatical relationships) anywhere in the title
- a difference that involves the name of the same corporate body and elements of its hierarchy or their grammatical connection anywhere in the title (e.g., the addition, deletion, or rearrangement of the name of the same corporate body, the substitution of a variant form)
- the addition, deletion, or change of punctuation, including initialisms and letters with separating punctuation vs. those without separating punctuation, anywhere in the title
- a different order of titles when the title is given in two or more languages on the *source of information*, provided that the title chosen as a title proper still appears as a parallel title proper

- the addition, deletion, or change of a word, words, or other component (i.e., a character or group of characters) anywhere in the title that links the title to the numbering
- two or more titles proper used on different issues of a serial in a regular pattern
- the addition to, deletion from, or change in the order of a word, words, or other component (i.e., a character or group of characters) in a list anywhere in the title, provided that there is no significant change in the subject matter
- the addition, deletion, or rearrangement anywhere in the title of a word, words, or other component (i.e., a character or group of characters) that indicates the type of resource, such as *magazine*, *journal*, or *newsletter* or their equivalent in other languages
