相關的RDA詞彙

- 電子資源是一種資源具體呈現 (manifestation)
- 將紙本資源電子化或是數位化是一種資源具體呈現的轉換
 - electronic reproduction of manifestation
 - A manifestation in a digital format that is the result of the transfer of a manifestation in an analog format.
 - *Inverse:* **electronic reproduction of manifestation of**
 - *Use for:* electronic reproduction (manifestation)

Manifestation

Definition and Scope

A physical embodiment of an expression of a work.

Prerecording

The term *manifestation* may refer to:

- an individual manifestation
- a part of a manifestation
- a *published manifestation*
- an *unpublished manifestation*

In RDA, transcription of data from the source ensures that, where applicable, the data reflects how a manifestation represents itself. Transcription can also function as a means of differentiating one manifestation from another.

For specific guidance about manifestation statements, see [Manifestation statements](#) →.

Manifestations of a work are sometimes available in different formats (e.g., as printed text and microfilm; as an audio disc and audiocassette). When this occurs, record the elements that apply to the carrier of the manifestation being described. Record relationships to other available formats as an RDA Entity: [related manifestation of RDA entity](#) →.

When describing a facsimile or reproduction, record the elements describing the carrier of the facsimile or reproduction. Record relationships to other available formats as an RDA Entity: [related manifestation of RDA entity →](#) .

This entity is an *entity subtype*.

For a more general description, use the *entity supertype*:

Describe an instance of an entity by recording a *metadata description set* that consists of one or more *metadata statements* using one or more elements assigned to the entity.

An element may be used more than once.

Use one or more of the recording methods to identify or label an entity.

Use one recording method to provide an appellation or IRI of an entity as a value of a relationship element.




LC/PCC practice: The PCC follows an interim approach to cataloging microform reproductions of print resources in the RDA environment. The general principle is to record descriptive elements for the print version, and give details of the microform reproductions, both those cloned from print version records and records created originally (i.e., no print record exists, or the cataloger chooses not to clone from the print record).

PCC practice: Use the "provider-neutral" approach described in the Metadata Guidance documents when *cataloging Print on Demand (POD) reproductions and photocopies of textual materials, scores, and cartographic materials*. This approach will result in a single PCC record that represents multiple POD reproductions and photocopies of the same original resource. **Do not apply this technique to regular print publications, republications, reprints, facsimile reproductions, etc., or to microform reproductions. Use this technique only when the entire content of both the original resource and the reproduction is identical.** Do not use it for a POD reproduction or photocopy of a book chapter or journal article. In case of doubt, do not apply this policy.

Online resources


OPTION

Record *online resource* as a Manifestation: [carrier type](#) for a manifestation that is accessed using a communications network.

Carrier type examples: **online resource**

A carrier type that consists of a digital resource accessed by means of hardware and software connections to a communications network.

CONDITION

An *online resource* is complete.

CONDITION OPTION

A carrier type that consists of a disc on which sound waves, recorded as modulations, pulses, etc., are incised or indented in a continuous spiral groove.

CONDITION

An *online resource* consists of two or more files.

A description of the characteristics of each file is considered important for identification or selection.

CONDITION OPTION

Record a separate Manifestation: [digital file characteristic](#) of each file.

Record a new instance of the entity when the following occurs:

An item that has not been modified has values of characteristics that differ from those of a manifestation.

A significant difference in a value of one or more other elements may indicate a boundary of the entity.

CONDITION

A manifestation has values of relationship, identifying, or carrier characteristics that differ from another manifestation.

CONDITION OPTION

Record a new instance of [Manifestation](#).

CONDITION

There is a significant difference in a value of Manifestation: [type of binding](#).

CONDITION OPTION

Record a new instance of [Manifestation](#).

相關的RDA & PCC規則 Manifestation (具體呈現): Entity boundary (5)

CONDITION

A work is a *diachronic work*.

There is a significant difference in a value of Manifestation: [carrier type](#) for the manifestation that embodies the work.

CONDITION OPTION

Record a new instance of [Work](#).

CONDITION OPTION

Relate a new instance [Work](#) to the other work using Work: [carrier version](#).

CONDITION

A work is a *diachronic work*.

There is a significant difference in a value of one or more characteristics of the plan for embodiment of the work over time.

Serials in LRM: WEM Lock

- Because serials may change over time, editions may diverge or converge. Consequently, LRM models each **serial as a unique *work* realized in a single *expression* that in turn is embodied in a single *manifestation*. This is called a WEM lock.**
 - LRM將每個連續性資源定位為個別獨立的作品，其內容透過單一表現形式、單一具體呈現做實現。
- Consequently, all relationships between serials are modeled as *work-to-work* relationships. LRM only defines these at the highest level
 - 不同連續性資源之間的關係，均為作品對作品的關係。
- Collocation of serials may be accomplished by defining additional entities in the model (e.g., ISSN-L to collocate serials in different formats)
 - 另定義附加的實體，達成連續性資源的聚集作用。

RDA規範對電子資源編目的原則與重點(包含實體, 線上電子資源)

- 根據LRM或是WEMI模型，實體與線上電子資源應該有不同的MARC記錄或是不同的manifestation data
 - 不可用混合記錄(hybrid or single record)
- Entity and relationship: related manifestations
- MARC fields: using 775 (reproduction) and 776 (related manifestation)
- 例外：期刊是用WEM Lock

- “RDA in the original RDA Toolkit and in the new RDA Toolkit is fundamentally the same.”*
- Work, Expression, Manifestation, and Item are still the entities we think about when describing resources. The properties of these entities are still called elements.
 - W (作品)、E (表現形式)、M (具體呈現)、I (單件) 仍為資源描述時的主要實體。各實體的屬性仍稱為元素。
- Many of the RDA terms from the original Toolkit have been retained when they do not conflict with [IFLA LRM](#).
- If you were already cataloguing in RDA, your data will not look much different in that same environment.

- The structure of the Toolkit has changed (Toolkit結構改變)
 - We will need to adapt how we look up and cite instructions.
- Community-specific instructions have moved out of the base text of RDA (特定編目社群所使用的資源描述指引)
 - Refer to policy statements, Community Resources, and community-driven guidance documents.
 - 參閱相關政策聲明、社群資源和社群導向的指導文件。

- RDA after 3R (Cont.)

- New terms allow us to address common complex scenarios (aggregates, diachronic works) or facilitate RDA data use for a linked data environment.
 - 加入新的詞彙，用以解決常見的複雜情境（聚合性資源、歷時作品），或促進RDA資料在鏈結資料環境中的應用。

- 如果你還沒有用RDA編目過，就必須瞭解WEMI模型和規範
- MARC記錄應該使用不同記錄，用775或776來鏈接
 - PCC將POD和微縮影片用不同規範和政策
- 鏈接數據應該是不同manifestation or instance
- 不同資源，各國或是協會可能有不同政策
- 可用Application profile來決定自館規範或是政策
- 期刊或是連續性資源與單本書是不同，是用WEM Lock
- PCC用Provider Neutral來控制同內容多平臺的問題

電子複製品與原紙本出版品的編目， 以及呈現兩者間書目關係的方式

- MARC：分開記錄
 - 用776來鏈接(不同的carrier)
- 鏈接資源：
 - 不同的manifestation
 - 建立分開的manifestation

衍生問題：

- 原生性電子資源跟電子複製品如何界定？
 - 電子複製品必須有紙本先行出版
 - 原生性電子資源可能沒有紙本，或是同時出版
- 有的出版品同時發行紙本跟電子版，則該電子版是否為原生性電子資源？
 - 也可以是，最重要是用**776**來鏈接紙本和電子資源
 - 也許多原生性電子資源是因為紙本被電子資源取代

Entity boundaries (實體界線)

- RDA definition: An RDA entity boundary is the set of criteria that is applied by an agent who creates metadata to ***determine if a description of a new RDA entity is required.***
 - 用以判定是否需描述為新的RDA實體的一組標準 (中文譯作實體界線、實體界限，或實體邊界)。
- Two types
 - **Absolute boundary** of the entity: determined by characteristics of the entity that reflect the physical world: Item, Manifestation, Person, Place and Timespan
 - 實體的絕對界線：由反映物理世界的特徵決定
 - **Relative boundary** of the entity: determined by bibliographic and cultural conventions
 - Some element values where a difference may or may not require a new entity description within a given implementation, for example, Manifestation: *date of manufacture*
 - 實體的相對界線：由書目與文化慣例決定

Work entity boundary

- A (static) work (靜態作品): a significant difference in:
 - Work (作品)
 - Subject or an element subtype; related agent of work or an element subtype; elements of an expression whose content differs from another realization of a work as the result of a change in genre or literary form, editorial policy, style; extension plan
 - Expression (表現形式): aggregates for the aggregating expression
- A diachronic work (歷時性作品) : a significant difference in:
 - Work (作品) : frequency or ISSN
 - Manifestation (具體呈現): carrier type
 - Characteristics of the plan for embodiment of the work over time

Diachronic work entity boundary (歷時性作品)

- Preferred title of work is in a language and script that divides text into words. There is a difference in a value of Work: preferred title of work that is a change in the first five words following an initial article, if any
 - 作品首選題名前5個字改變（首冠詞省略不計）。
- Preferred title of work that is a change in meaning or an indication of a different subject
 - 作品首選題名意義或表示的主題改變。
- Preferred title of work that is a change in a value of Corporate Body: name of corporate body
 - 作品首選題名中，團體名稱部分的著錄值產生改變（當含有團體創作者時）

Example: major changes requiring a new serial work (2)

- **LC/PCC Practice**

- When deciding to update an existing Work or create a new Work, compare the title on that issue or part to the title proper in the MARC 245 field in the serial bibliographic record and not against the variant titles in the MARC 246 fields.
 - 當要決定是更新既有的作品描述，還是另創新的作品描述，以在編卷期（或部分）上所題載的題名，與可能相關的書目紀錄欄位245做比對（不要與246比對）。
