#### Introduction

### 編輯者簡介

美國書目合作計畫 (BIBCO, Bibliographic Cooperative Program) 及期刊合作計畫 (CONSER, Cooperative ONline SERials) 為能確保在共享資料庫中書目記錄的品質,根據舊版 RDA (Original RDA) 規則編寫了這兩個文件。這兩個文件列出最基本的元素、相對應的 RDA 規則編號、基本說明、及相關的 MARC 21 欄位。這些元素只是這兩個合作計畫的要求,編目員可根據其圖書館需求增加其他元素,也可參考其他編目團體所出版的最佳實務指引 (best practice),如非書資料編目員組織 (OLAC, On-line Audiovisual Catalogers, Inc.) 所出版的「光碟、藍碟、物件、串流媒體、及電動遊戲編目最佳實務指引:根據舊版 RDA 及 MARC 21 (OLAC best practices for cataloging DVD-Video and Blu-ray discs, objects, streaming media, and video games using the Original RDA Toolkit and MARC21」。

這兩個文件包含的資源類型有:檔案、錄音、地圖、電子、圖像、動態影像、樂譜、善本特藏、及文字類型。同時也列出電子複製資源。雖然文件中有列出對善本、特藏資源的說明,編目員仍需參考 Descriptive Cataloging of Rare Materials (DCRMs) 說明。如使用 DCRMs,則另加一欄位 040 分欄 e (\$e) 登錄此資訊,如 040 \$e rda \$e dcrm。

為幫助臺灣編目人員工作,同時減少翻閱尋找兩個文件,編輯者將此兩個文件合併成一。又因此文件上只有舊版 RDA 的規則號碼,為能幫助編目人員進入新版 RDA (RDA Toolkit)的環境,編輯者加上相對應的新版 RDA 規則路徑,以紅色字列出在表格的「說明」直行中。
